

## 16. FACIAL MAKEUP APPLICATION (20 minutes)

+ ADDITIONAL SECTION +

**Proctor – Verbal Instructions:** Read to all candidates:

*“You have 2 minutes to set up the supplies for the Facial Makeup section of this examination.”*

*“Please do not begin to demonstrate the procedure at this time.”*

*“Step back to indicate you have finished.”*

(1) *“The instructions will be repeated.”*

(2) *“You may begin.”*

**Proctor – Verbal Instructions:** Read if all candidates have stepped back to indicate they have completed the section before the timing has elapsed:

*“All candidates have indicated they have completed this section. Please do nothing until the next verbal instructions are given.”*

**Proctor – Verbal Instructions:** Read if the timer goes off before all candidates have stepped back:

*“Please stop working. Please do nothing until the next verbal instructions are given.”*

**Proctor – Verbal Instructions:** Read to all candidates:

*“You will prepare your client for services.”*

*“You will apply facial makeup.”*

*“You will be expected to apply facial makeup to include foundation, powder, blush, eyeshadow, eyeliner, mascara, and lip color.”*

*“You will have 20 minutes to complete this section.”*

*“You will be informed when you have 10 minutes remaining.”*

*“Step back to indicate you have finished.”*

(1) *“The instructions will be repeated.”*

(2) *“You may begin.”*

**Candidates will be evaluated on the following tasks:**

**16.1 Facial makeup supplies are labeled in English**

**16.2 Implements and supplies are visibly clean**

**16.3 Applies foundation to cover face**

**16.4 Applies powder**

**16.5 Applies blush**

**16.6 Applies eyeshadow**

**16.7 Applies eyeliner**

**16.8 Applies mascara**

**16.9 Applies lip color**

**16.10 Maintains drape throughout section**

**16.11 Places items to be disinfected, soiled linens, and trash in correct containers throughout section**

#### **Information related to labeling of supplies:**

- ALL supplies must be labeled in English
- No other languages can be present unless an original manufacturer’s label is present
- Original manufacturers’ labels MUST have English and may be multi-language
- All other created labels must be only English

#### **FACIAL MAKEUP APPLICATION SUPPLIES**

- blush
- body drape
- disposable applicators
- eye shadow
- eyeliner
- foundation
- hair band or drape
- lip color
- mascara
- palette (no single use makeup, all makeup must be transferred *PRIOR* to use)
- powder
